Experience

Recent highlights	 Sebastian represented the buyer of a commercial property in a high-court case, where the buyer demanded a proportionate reduction of the purchase price due to the seller's incorrect information on pending rental cases as part of the due diligence process. The Eastern High Court ruled in full favour of the buyer, as the information was to be considered a warranty not subject to the buyer's duty of inspection. Sebastian represented a company in a high-court case against a bank concerning increases of the interest surcharge/margin and changes of the base interest rate for an overdraft facility during the commitment period. The company was successful in its claim for repayment before the Western High Court, despite having received continuous information on the changes. Sebastian represented the seller of a commercial property in a high-court case against the buyer as to whether any refund from the Danish tax authorities to the seller, following the buyer taking possession of the property, was to accrue to the seller or the buyer. The Eastern High Court
	found that the seller was to pay no amount to the buyer despite the buyer having already refunded the amount to the seller in the statement of operating income.
